In the references 4th read above, the Member Secretary, Telangana State Pollution Control Board has stated that, Govt. of Telangana constituted Telangana Pollution Control Appellate Authority for State of Telangana under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 comprising of retired High Court Judge and two Technical Members for a period of 2 years vide G.O.Ms.No.39, EFS&T (For.III) Dept., Dt.03-08-2021 and the term of the Appellate Authority expired on 03.08.2023 and requested the Government for re-constitution of the Telangana Pollution Control Appellate Authority.
